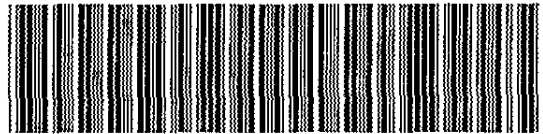


ARTICLE VII AMENDMENT
