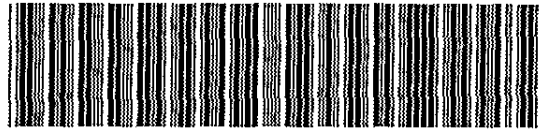

ARTICLES OF INCORPORATION

OF

FARI'S INCORPORATED

ARTICLE I - NAME

The name of this corporation is Farhat Incorporated and the address is 1600 Eagles Landing Boulevard, Apartment #58, Tallahassee, Florida 32308.

ARTICLE II - TERM OF EXISTENCE

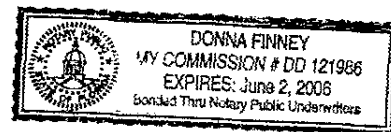
