We, the undersigned subscribers to these articles of incorporation, natural persons LAHASSEE, FLORIDA competent to contract, hereby form of Corporation under the Laws of State of Florida.

ARTICLE I, NAME OF CORPORATION:

The name of the Corporation shall be:
