ARTICLES OF INCORPORATION

OF

P.A.D. FREIGHTLINES, INC.

EFFECTIVE DATE

05-07-03

The undersigned, acting as incorporator of this Corporation pursuant to Chapter 607 of the Florida Statutes, hereby forms a corporation for profit under the laws of the State of Florida and adopts the following Articles of Incorporation for such Corporation:

ARTICLE I - NAME OF CORPORATION

The name of this Corporation shall be P.A.D. FREIGHTLINES, INC..

ARTICLE II - PRINCIPAL OFFICE

The principal office of this Corporation shall be located at 189 Pinewood Lane, Winter Haven, Florida 33881-9117.

ARTICLE III - DATE OF EXISTENCE

This Corporation shall exist perpetually, commencing on the date of execution of these Articles of Incorporation.

ARTICLE IV - CAPITAL STOCK
