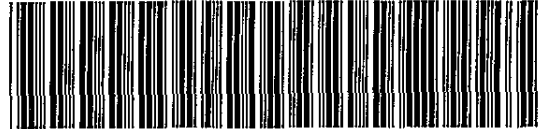

The name of this corporation shall be Markers and More, Inc.

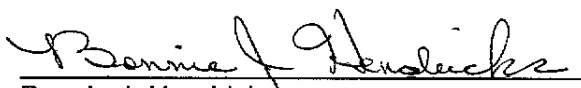

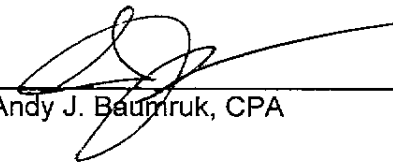
