I, the undersigned, being of legal age and a natural person, do hereby subscribe to, acknowledge and file the following Articles of Incorporation for the purpose of creating a corporation under the laws of the State of Florida.

### ARTICLE I

The name and initial address of this Corporation shall be: ALL AMERICAN COMMERCIAL CLEANING, INC., 214 Brazilian Avenue, Suite 220, Palm Beach, Florida 33480.

#### ARTICLE II
