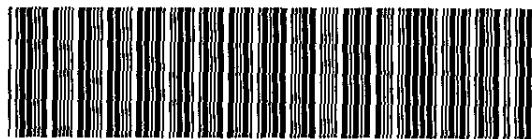

ARTICLES OF INCORPORATION

OF

PRECISION INFLUENCE TECHNOLOGIES, INC. 03 MAY 12 AM 9:36

ARTICLE I - NAME:

The name of this corporation is: PRECISION INFLUENCE TECHNOLOGIES, INC., hereinafter referred to as the "Corporation".

ARTICLE II - DURATION:

The Corporation shall exist perpetually, commencing upon the filing of the Articles of Incorporation with the Department of State.

ARTICLE III - PURPOSE:

The Corporation is organized for the purpose of engaging in the Consulting business and for the purpose of transacting any or all other lawful business not inconsistent with Laws of the State of Florida.

ARTICLE IV - CAPITAL STOCK:

The Corporation is authorized to issue 100,000 shares of One Dollar (\$1.00) par value common stock.

ARTICLE V - PRE-EMPTIVE RIGHTS:

Every shareholder, upon the issuance of any new stock of the same kind, class or series as that which he or she already holds, whether for or without consideration, including but not limited to new stock issued as compensation to directors, officers, agents or employe of the corporation or to satisfy conversion or option rights; shall have the right to purchase his or her pro-rata share thereof (as nearl as may be done without the issuance of fractional shares) at the same price at which it is offered to others.
