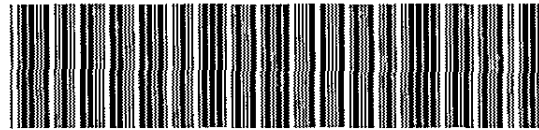

ARTICLE II - DURATION

The corporation shall have a perpetual existence.

ARTICLE III - PURPOSE

The purpose of this corporation is to engage in the business of recycling of paper, cardboard, plastics, glass and any other activity permitted under the laws of the United States and the State of Florida.

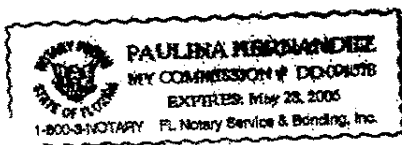

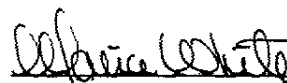
