



#### ARTICLE I - NAME AND PRINCIPAL ADDRESS

The name of the corporation Dura-Made, Inc., and the principal address and principal place of business is 1592 Eagles Reach Drive, Tarpon Springs, FL 34689.

#### ARTICLE II - REGISTERED OFFICE AND AGENT
