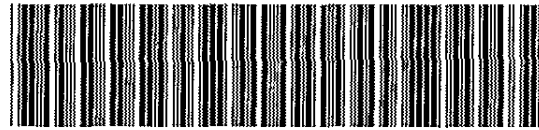

ARTICLE I - NAME

This corporation is organized for the purpose of

ARTICLE IV - CAPITAL STOCK
