ARTICLES OF INCORPORATION OF

1. **ARTICLE I Name.**

6. **ARTICLE VI CAPITAL**

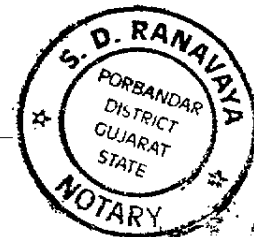
The amount of capital with which this corporation will begin business is Five Hundred Dollars.

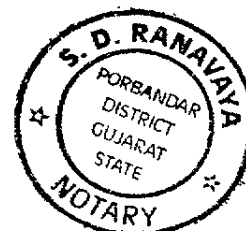
