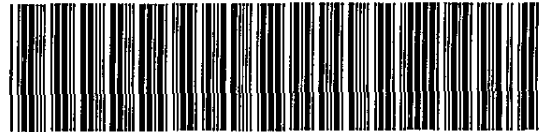

FOR

ARTICLE I

The name of this corporation is YVONNE L. SOULE, P.A.

ARTICLE II

This corporation is organized for the purpose of engaging in transacting any lawful business permitted under the laws of the United States and the State of Florida. The principle business activity of this corporation is real estate services.


