ARTICLES OF INCORPORATION

FOR

E. GLENN HENNIG, JR., PHD, P.A.



The undersigned, desiring to form a corporation under and by virtue of the laws of the State of Florida providing for the formation, liability, rights, privileges and immunities of a corporation for profit, states as follows:

ARTICLE I Name and Address of Corporation

The name of this corporation shall be E. Glenn Hennig, Jr., PHD, P.A., and the mailing address is 1111 S. Orange Ave. #300, Orlando, FL 32706.

ARTICLE II Objects and Purposes of Corporation

The objects and purposes of the corporation and the general nature of the business or businesses to be transacted shall be:

- 1. To engage in the practice of clinical psychology.
- 2. To engage in any lawful businesses permitted or allowed under the Florida General Corporation Act.
- 3. To make and enter into all contracts necessary and proper for the conduct of its business or businesses.
- 4. To borrow money from any person, firm, or corporation; to issue bonds, debentures, or obligations of this corporation from time to time for any of the objects or purposes of the corporation; and to secure same by mortgage, pledge or by any other lawful means.
- 5. To have offices, conduct its business and promote its objects within or without the State of Florida, in other states, the District of Columbia, the territories and possessions of the United States, and in foreign countries without restriction as to place or amount.
- 6. To do any and all things necessary, suitable and proper for the accomplishment of any of its objects or for the exercise of any of the powers set forth above, whether herein specified or not, either alone or in connection with other firms, individuals, or corporations, whether in the State of Florida, or throughout the United States, or elsewhere, and to do any other act or acts,

thing or things incidental or pertinent to or connected with the businesses hereinbefore described, or any part or parts thereof, if not inconsistent with the laws of the State of Florida.

7. In general, this corporation shall have and exercise all the powers conferred by the laws of the State of Florida upon corporations for profit. It is hereby expressly provided that the foregoing enumeration of specific powers shall not be held to limit or restrict in any manner such general powers.

ARTICLE III Term of Existence

Identity of Incorporator; Pre-emptive Rights

ARTICLE X

Annual Meeting of Shareholders

- 1.
