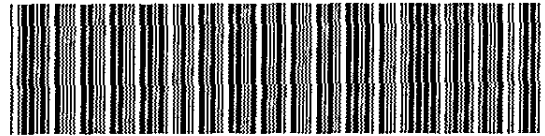



The number of shares the corporation is authorized to issue is One Hundred (100), of one class only, with no par value.


