ARTICLE OF INCORPORATION
OF

The undersigned subscribers to this Article of Incorporation, natural persons competent to contracts, hereby form a corporation under the laws of the State of Florida.

ARTICLE I. NAME

The name of the corporation shall be:

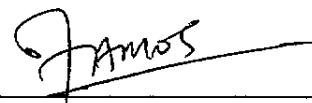

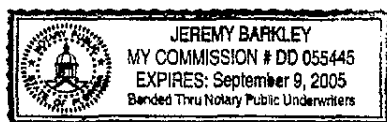
