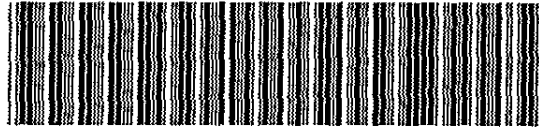

Articles of Incorporation for

The undersigned incorporator hereby forms a corporation under the laws of the state of Florida.

ARTICLE I

The name of the corporation is:
