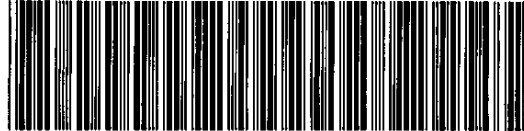


SECOND: The date of the adoption of these Articles of Dissolution is 8 June 2006.
