This letter is to address the non-payment for the re-instatement of my corporation: Healthier With Us Services, Inc. located at 1850 S.W. 8 Street #305 Miami, FL 33135. On Monday June 5, 2003, I hired an office manager, whose duties entailed the responsibility of accounts payable and receivable, payroll, billing/collections, customer service, basically handling all of the corporations' responsibilities.
