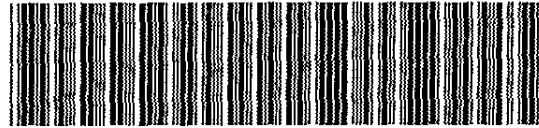

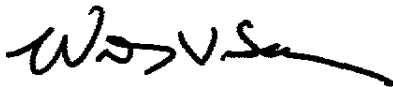

The undersigned, acting as incorporator, signs the following Articles of Incorporation for the purpose of forming a Florida professional association under the laws of the State of Florida.

**ARTICLE I**

The name of the corporation shall be:

**ARTICLE II**

The existence of the corporation shall commence upon the filing of these Articles of Incorporation by the Department of State and shall be perpetual.

**ARTICLE III**

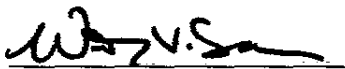
