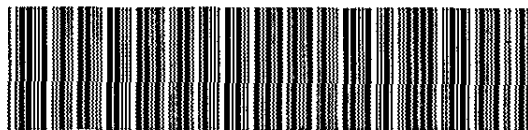

We the undersigned, hereby associate ourselves together for the purpose of becoming a corporation under the laws of the State of Florida providing for the formation, liability, rights, privileges and immunities of corporations for profit.

**Article I. Name**

The name of the corporation shall be:

**Article II. Nature of Business**



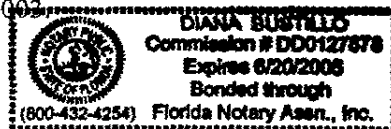
