ARTICLE I. NAME



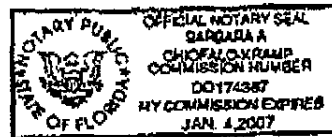
