The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopt the following Articles of Incorporation:

ARTICLE I

The name of the corporation is CHARLES F. FINK, INC., with its principal office and mailing address at 5342 NW 92ND LANE, CORAL SPRINGS, FLORIDA 33067.

The duration of the corporation is perpetual.
