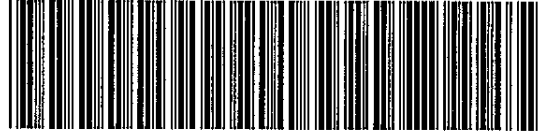

Under the laws of the State of Florida:

ARTICLE I

NAME:

M & V ENTERPRISES OF SOUTH FLORIDA, INC.

ARTICLE II

PURPOSE:

The corporation is organized to engage in any and all business
permitted under the laws of the State of Florida.

ARTICLE III

CAPITAL STOCK:

The maximum number of shares of stocks which this corporation is
authorized to issue is 7500 shares of \$ 1.00 par value, common stock.
Said shares of stock may be issued only for a consideration having a
fair value as may be determined by the board of directors.

At each election for Directors, cumulative voting by shareholders as set forth in Florida Statutes, Chapter 607.097 (4) shall be allowed.



AMENDMENT:


These Articles of Incorporation may be amended in the manner provided by law. Every amendment shall be approved by the Board of Directors, proposed by them to the stockholders and approved at a
