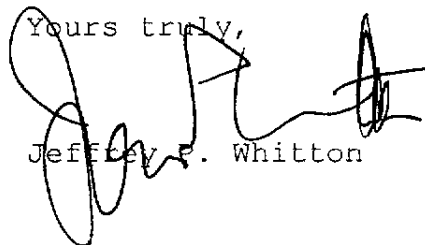

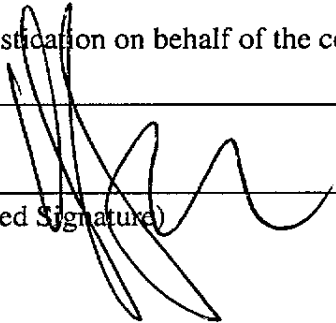

ARTICLE VI

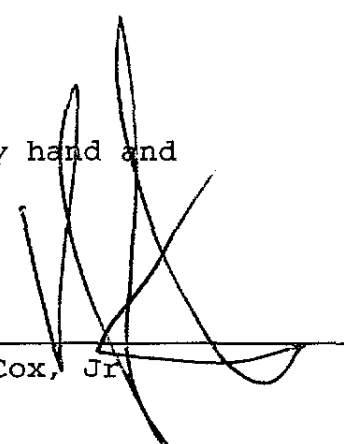

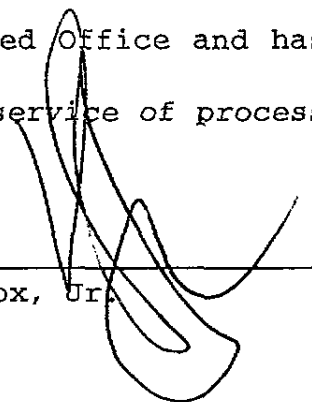
