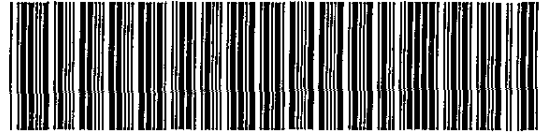

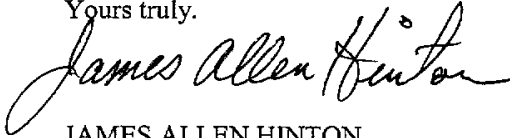

The name of this corporation shall be: FIRST COAST HOUSE DOCTORS, INC.

ARTICLE II - PRINCIPAL PLACE OF BUSINESS

The principal place of business of this corporation shall be:

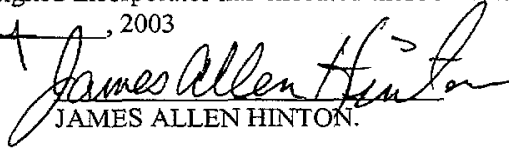
ARTICLE X - INDEMNITY

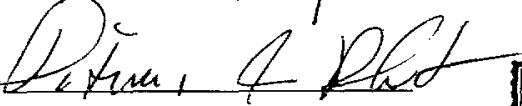

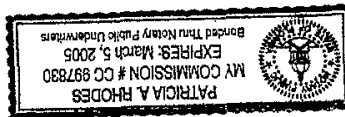

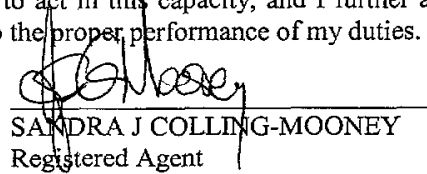
