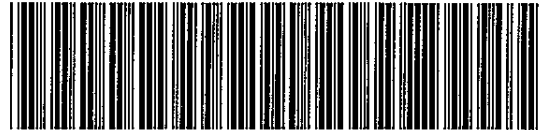

**ARTICLES OF INCORPORATION
OF

**ARTICLE I

ADDRESS

This corporation shall have perpetual existence.

DIRECTORS
