

**ARTICLES OF INCORPORATION**  
**OF**  
**MOE CITY FARMS, INC.**

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

**ARTICLE I**

**Name**

The name the Corporation shall be MOE CITY FARMS, INC.

**ARTICLE II**

**Principal Office and Address**

The principal place of business and mailing address is 7228 Castle Drive, Sarasota, Florida 34240.

**ARTICLE III**

**Duration**

The duration of the Corporation is perpetual.


