

## ARTICLES OF INCORPORATION OF MOE CITY FARMS, INC.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

#### ARTICLE I Name

The name the Corporation shall be MOE CITY FARMS, INC.
