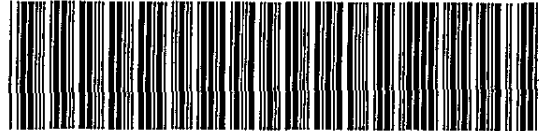

ARTICLE I

THE NAME OF THE CORPORATION SHALL BE:

THIS CORPORATION SHALL HAVE PERPETUAL EXISTENCE.

ARTICLE III

THIS CORPORATION IS ORGANIZED FOR THE FOLLOWING PURPOSES:

- A. TO ENGAGE IN CARPET SERVICES OF ANY TYPE OR NATURE
