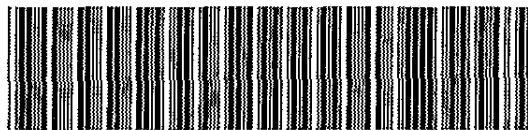

The name of this corporation is: R.G. ELKINS, INC.

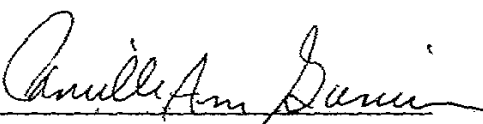

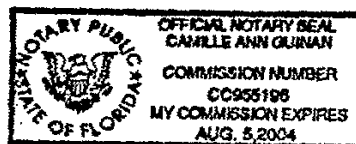

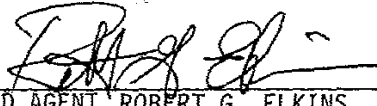
