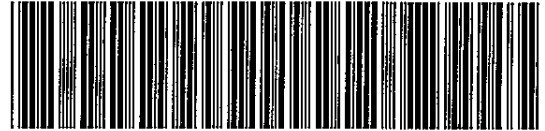



**Initial Registered Office and Agent**





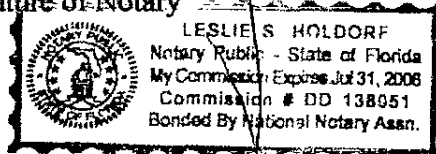
