ARTICLES OF INCORPORATION

OF

JMM MANAGEMENT ENTERPRISES, INC.

ARTICLE I - NAME:

The name of this corporation is: JMM MANAGEMENT ENTERPRISES, INC., hereinafter referred to as the "Corporation".

ARTICLE II - DURATION:

The Corporation shall exist perpetually, commencing upon the filing of the Articles of Incorporation with the Department of State.

ARTICLE III - PURPOSE:

The Corporation is organized for the purpose of engaging in for the purpose of transacting any or all lawful business not inconsistent with Laws of the State of Florida.

ARTICLE IV - CAPITAL STOCK:

The Corporation is authorized to issue 100,000 shares of One Dollar (\$1.00) par value common stock.


ARTICLE IX - BY-LAWS:

ARTICLE X - SECTION 1244 STOCK:


