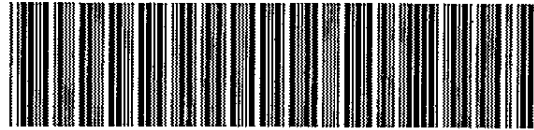

ARTICLES OF INCORPORATION
OF
S. M. T. MONEY SHOWS, INC.

ARTICLE I - Name

The name of this corporation is S. M. T. MONEY SHOWS, INC.

ARTICLE II - Purpose

The general nature of the business to be transacted by this corporation shall include the transaction of any and all lawful business for which corporations may be incorporated under Chapter 607, Florida Statutes and to sponsor public forums for precious coin trading and related merchandise.

ARTICLE III - Capital Stock

The authorized capital stock of this corporation shall be 100 shares of common stock with a par value of \$5.00 per share.

ARTICLE IV - Period of Existence

The corporation shall have perpetual existence unless sooner dissolved by law.

ARTICLE V - Registered Office and Registered Agent

The street address of the initial office of this corporation is 4019 Central Avenue, City of St. Petersburg, County of Pinellas, State of Florida, 33713, and the name of the initial registered agent of this corporation VICTOR INGRAFFIA at 27001 U.S. Hwy. 19 North, #8520, Clearwater, Florida, 33761.

ARTICLE VI - Initial Board of Directors

This corporation shall have two (2) directors initially. The number of directors may be either increased or diminished from time to time by the By-Laws, but shall never be less than one (1). The

names and addresses of the initial members of the Board of Directors of this corporation are: MARC EARLE, 4019 Central Avenue, St. Petersburg, Florida, 33713, and VICTOR INGRAFFIA, 27001 U.S. Hwy. 19 North, #8520, Clearwater, Florida, 33761.

ARTICLE VII - Incorporator

The name and address of each initial incorporator of this corporation is: MARC EARLE, 4019 Central Avenue, St. Petersburg, Florida, 33713, and VICTOR INGRAFFIA, 27001 U.S. Hwy. 19 North, #8520, Clearwater, Florida, 33761.

ARTICLE VIII - By-Laws

All By-Laws shall be approved by a majority vote of the shareholders, and all modifications or additions to the By-Laws shall be ratified by a majority vote of the shareholders before such modification or addition shall become effective.

ARTICLE IX - Indemnification

The corporation shall indemnify any officer, director, or any former officer or director, to the full extent permitted by law for such acts of the officer or director, or former officer or director, while acting in a corporate capacity.

ARTICLE X - Amendment

The shareholders reserve the right to amend or repeal any provision contained in these Articles of Incorporation, any amendment hereto, or any right conferred on shareholders by majority vote.

ARTICLE XI - Section 1244 Stock

It is the intention of the incorporators of this corporation that the first board of directors adopt a plan under Section 1244 of the Internal Revenue Code allowing a limited ordinary loss to

individuals for loss on stock of a "Small Business Corporation" which qualifies under the Code.

ARTICLE XII - Voting Rights


Except as otherwise provided by law, the entire voting power for the election of directors and for all other purposes shall be vested exclusively in the holders of the outstanding common shares.

ARTICLE XIII - Pre-Emptive Rights

Every shareholder, upon the sale for cash of any new stock of this corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his prorata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

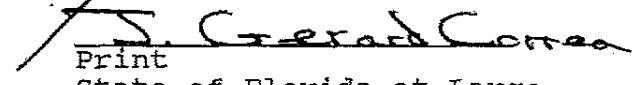

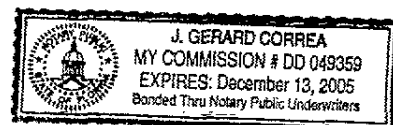

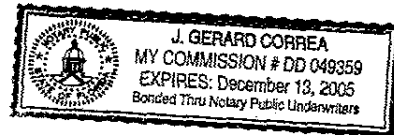
