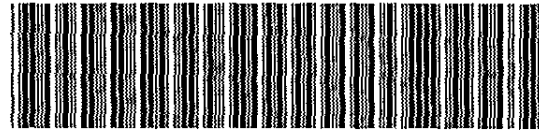

The name of this corporation is CRAIN ALUMINUM, INC.


ARTICLE IX. BY-LAWS
