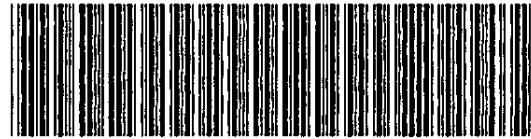



**MINUTES OF A SPECIAL MEETING OF DIRECTORS
OF
WALLER PROPERTY MANAGEMENT, INC.**

A special meeting of the Board of Directors of the corporation was held at the time, date, and place set forth below.

All of the directors being present, the meeting was called to order by the Chairman. The Chairman advised that all of the stockholders had executed consents, either written or verbal, to various corporation matters. Upon motion duly made, seconded, and unanimously carried, it was

RESOLVED, that in the judgement of the Board of Directors of the corporation, it is deemed advisable and for the benefit of the corporation that it should be liquidated and dissolved, and it was further

RESOLVED, that, subject to approval of the stockholders of the corporation and effective with the date of such approval, a plan of liquidation be, and it hereby is, formulated to effect such liquidation and dissolution in accordance with the following resolutions, and it was further

RESOLVED, that the proper officers of the corporation be, and they hereby are, authorized and directed to sell or otherwise liquidate any and all of the properties and assets of the corporation which, in their judgement should be sold or liquidated to facilitate the liquidation of the corporation, and it was further

RESOLVED, that the proper officers of the corporation be, and they hereby are, authorized and directed to file a Certificate and/or Articles of dissolution with the Secretary of State, State of FLORIDA, and it was further

RESOLVED, that after providing for all proper debts of the corporation, the remaining assets of the corporation be distributed to the stockholders of record of the corporation, and it was further

RESOLVED, that the actions provided for in the foregoing resolutions providing for the complete liquidation of the corporation and the distribution of its assets be commenced as soon as practicable, and that such assets be distributed and the dissolution be completed as soon as practicable, but in no event later than the termination of a twelve (12) month period commencing with the date of shareholder approval of this plan of complete liquidation, and it was further

RESOLVED, that the proper officers of the corporation be, and they hereby are, authorized and directed to pay any and all such fees and taxes, and to do or cause to be done such other acts and things as may be deemed necessary or proper in order to carry out the liquidation and dissolution of the corporation and to fully effectuate the purposes of the foregoing resolutions, and it was further

RESOLVED, that a special meeting of stockholders be called to consider the above resolutions, and it was further

RESOLVED, that the signing of these minutes shall constitute full ratification thereof and waiver of notice of the meeting by the signatory.

It is intended that this liquidation be in accordance with Section 331 of the Internal Revenue Code of 1986, as amended, and accordingly, all assets will be liquidated and final distributions made to the stockholders of record of the corporation within twelve (12) months of this date.

There being no further business to come before the meeting, upon motion duly made, seconded, and unanimously carried, the meeting was adjourned.
