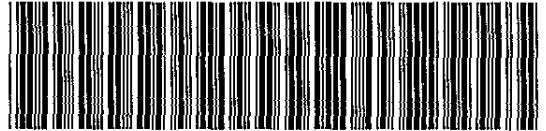

ARTICLE I - NAME

The name of this corporation is Boot Assessment and Services, Inc.

ARTICLE II - PRINCIPAL OFFICE
