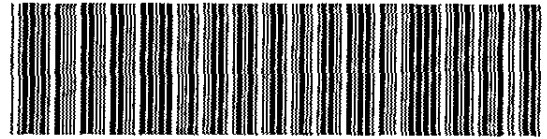

**ARTICLES OF DISSOLUTION  
OF

Pursuant to Section 607.1401 of the Florida Business Corporation Act, ROCHELLE MYERS, INC., a Florida corporation, hereby adopts the following Articles of Dissolution:

**ARTICLE I**

**Name; Date Articles of Incorporation Filed**
