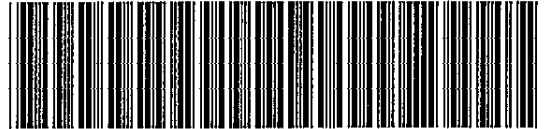

**ARTICLE V - TERM OF EXISTENCE**




