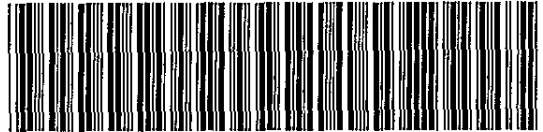



**ARTICLES OF INCORPORATION  
OF

**ARTICLE I - NAME**

The name of this corporation is Everlite Business, Inc. and the address is 1725 Noah's Ark Road, Jonesboro, Georgia 30236.

**ARTICLE II - TERM OF EXISTENCE**

This existence of this corporation shall exist perpetually.
