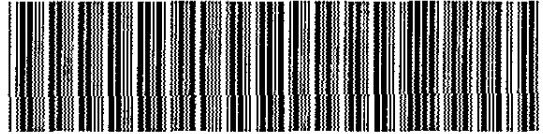

ARTICLES OF INCORPORATION

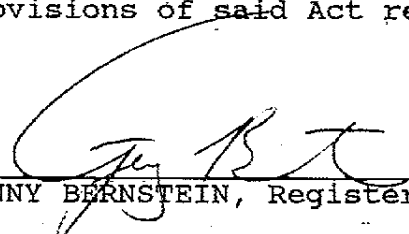
