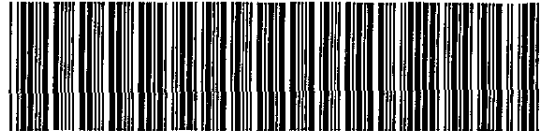

ARTICLES OF INCORPORATION OF
Copeland & Cordero Insurance and Financial Services, Inc.

ARTICLE 1 - Name

The name of the corporation is: Copeland & Cordero Insurance and Financial Services, Inc.

ARTICLE II – Existence

This corporation shall commence existence upon receipt and filing of these articles.

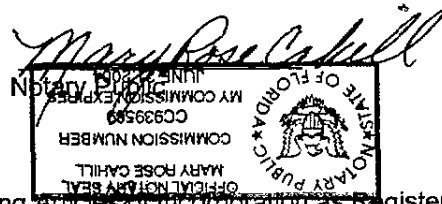
