The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, does hereby adopt the following Articles of Incorporation:

**ARTICLE I
NAME AND ADDRESS**

The name of the Corporation shall be: PATRICK INDUSTRIAL PARK, INC.

DURATION**

BUSINESS, OBJECTS OR PURPOSE**


