ARTICLE I - NAME AND BUSINESS ADDRESS

The name of this Corporation is My Youths, Inc. Its principal office address and business mailing address is 2706 Sunshine Boulevard, Miramar, Florida 33023.

ARTICLE II - DURATION

The Corporation shall have a perpetual existence.

ARTICLE III - PURPOSE

The purpose of this Corporation is to engage in any activities or business permitted under the Laws of the United States and Florida.

ARTICLE IV - CAPITAL STOCK
