




The undersigned, acting as incorporators of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation.

#### ARTICLE I

#### ARTICLE II

The period of duration is perpetual.

#### ARTICLE III

The purpose for which the corporation is organized is to operate a doctor's office under the laws of the United States and of this state.
