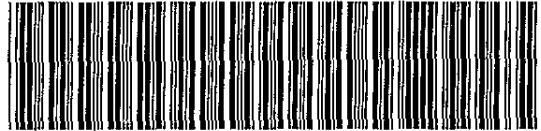

**ARTICLE 1 - NAME**

The name of this corporation is **AMANDA S. KIRKLAND, P.A.**

**ARTICLE II - DURATION**

This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.

**ARTICLE III - PURPOSE**

This corporation is organized for the purpose of transacting any or all lawful business, including but not limited to the following:

To buy, sell, exchange and generally deal in real properties, improved and unimproved, and buildings of every class and description; to improve, manage, operate, sell, buy, mortgage, lease or otherwise acquire or dispose of any property, real or personal and take mortgages and assignment of mortgages upon the same; to make and obtain loans upon real estate, improved or unimproved, and upon personal property; and to act as agent or broker for any other person, firm or corporation in doing any all acts described herein.


#### ARTICLE IX - INDEMNIFICATION



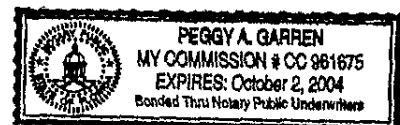
