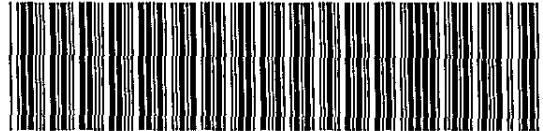

**ARTICLES OF INCORPORATION  
OF

The undersigned acting as incorporator of a Florida corporation under Chapter 621 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such Corporation:

**ARTICLE I – NAME AND BUSINESS ADDRESS**

**ARTICLE III – DURATION**

The Corporation shall have a perpetual existence.

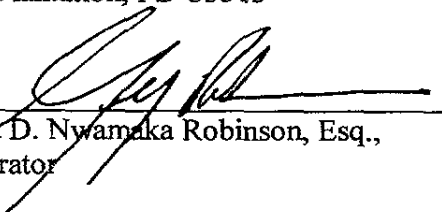

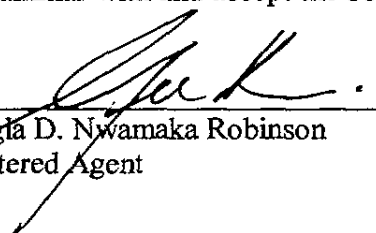
