The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

ARTICLE I. NAME

The name of the corporation shall be: FIBA Auto Sales, Inc. The principal place of business of this corporation shall be 117 Sawtooth Lane, Ormond Beach, Florida, 32174, and the mailing address of business shall be 117 Sawtooth Lane, Ormond Beach, Florida, 32174.

ARTICLE II. NATURE OF BUSINESS



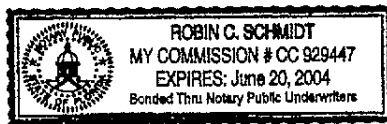
