## **ARTICLES OF INCORPORATION**

### **ARTICLE I - Name**

The name of this corporation is **Alamo Consulting Group, Inc.**

### **ARTICLE II - Principal Office**

The mailing address of this corporation shall be: 9301 S.W. 60 Street, Miami, FL 33173.

### **ARTICLE III - Purpose**

#### **ARTICLE X - Indemnification**

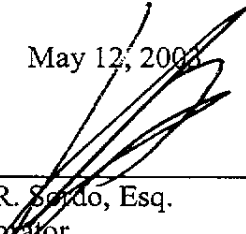
The corporation shall indemnify any Officer or Director, or any former Officer or Director, to the full extent permitted by law.

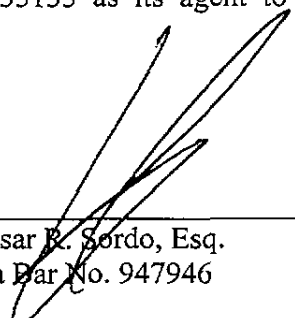

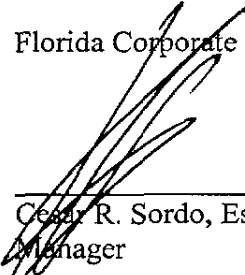
