ARTICLES OF INCORPORATION **ALIEN STATION CORPORATION**

ARTICLE I. NAME

The name of the corporation is ALIEN STATION CORPORATION.

ARTICLE II. DURATION AND COMMENCEMENT OF EXISTENCE

The corporation is to have perpetual existence, commencing at the filing of these articles with the Department of State.
