ARTICLES OF INCORPORATION
OF VILLOLDO FELLSMERE FARMS, INC.

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I - NAME

The Articles of Incorporation may be amended as provided by law.


ARTICLE XII - VOTING RIGHTS


